## August Mayor's Notes

Most of you have been following our involvement regarding the home at 7616 Old Salem Rd. I am pleased to report that the home did sell at the court auction held on July 12. We will within a very short period of time be receiving a complete accounting of the transaction and a reimbursement of some if not all of the expenses incurred by the city over this process. I believe our new neighbors have moved in already, or at least are working on renovating so if you see them working, introduce yourself and make them feel welcome to their new city.

School is about to begin again and as our city has grown with young families, please keep a close eye on the road ahead of you as you traverse the city.

The election season is upon us and I would like to invite anyone with even a slight interest in and after the Nov. 5 election, we will likely end up with a seat on the commission vacant beginning January 1, 2025. We do have the ability to appoint and would be pleased to answer any questions involved regarding involvement. I can tell you the pay is not great... but the satisfaction is even greater.

#### **Meeting Notes:**

We have one resident interested in participating on the commission beginning January '25. That still leaves one vacancy. As of Sunday eve, I have no final \$372,000. The law firm working with Richard Schiller on this has stated that the final accounting should be forthcoming.

Charlie Veeneman called me last Thursday evening to tell me about the "fraud" statements that we all received. I hope you have returned them. Additionally, he stated he will do his best to have the "draft audit" completed before Labor Day. He will undergoing some surgery and will be delayed by that. If he can get a peer review done quickly, it will be finished.
