# FRIENDLY TRASH REMINDER

Bancroft City Ordinance 50.16 requires residents to remove empty garbage/recycle/yard waste cans from street-side by midnight on the day of pick up. If Rumpke fails to pick up your garbage/recycle/yard waste, first call Rumpke (568-3800) to request pick up, then call or email the City Commissioner for Public Services.

# HOW CAN WE CONTACT THE POLICE?

### For immediate police assistance:

- 1. Emergency: Dial 911
- 2. Non-emergency police assistance: Dial 311

### For non-urgent neighborhood concerns:

1. Call our police line at **(502) 263-3663.** Leave a voicemail with your name and phone number. Chief Mudd will call you back when he is on duty.

For your safety, please call 911 or 311 to have police dispatched. If Chief Mudd is working, then they will dispatch him to help you, otherwise, they will dispatch a Metro police officer. Do not personally seek out Chief Mudd to get assistance for an emergency.

# House Watch


